Judge Vanessa D. Gilmore United States District Judge Southern District of Texas Houston, TX

In 1994 when Judge Vanessa Diane Gilmore was sworn in, she was then the youngest sitting federal judge in the nation. The native of Silver Spring, Maryland was also the youngest member of her freshman class at her alma mater, Hampton University. Gilmore decided to undertake a career in law after she represented herself and won a minor civil lawsuit. She graduated from the University of Houston Law Center in 1981.

In 1982, Gilmore began a 13-year tenure at a Houston law firm that later became known as Vickery, Kilbride, Gilmore & Vickery. There she specialized in civil litigation. Gilmore became an active member of the Houston civic community, serving on the boards of a number of organizations including the YWCA, Child Advocates, End Hunger Network and the Houston Ballet. She also became involved in the Texas political arena while serving as counsel and teacher in the area of election law.

Her civic activities outside of the courtroom brought her to the attention of Governor Ann Richards who in 1991 appointed Gilmore to the Texas Department of Commerce Policy Board, where she also served as chairperson from 1992 to 1994. Her appointment to that board made Judge Gilmore the first African-American to serve on this board responsible for increasing business, tourism, and job training development in Texas. In 1993, she also served as chairperson of Texans for NAFTA. In this capacity, she worked regularly with diplomatic leaders, including the President of Mexico, to increase U.S. trade opportunities. Judge Gilmore was nominated to the federal bench by President Bill Clinton in 1994 and became the first University of Houston graduate to be appointed to the Federal bench. She is a sought after lecturer and speaker and has published noteworthy opinions on patients' rights, copyright and patent law and the first amendment. She serves on the board and advisory boards of a number of charitable organizations including the Houston Zoo, San Jacinto Girl Scouts, Spaulding for Children and Habitat for Humanity, and on the Board of Trustees for Hampton University. She is the recipient of numerous civic awards for community service and is a member of Wheeler Avenue Baptist Church, the Missouri City Chapter of Links and Jack & Jill of America, Houston Chapter. She has co-authored a book for the children of incarcerated parents and is currently at work on three books related to adoption including a children's book. She is the proud mother of one son.

Dr. Jane E. Smith is Executive Director of the Spelman College Center for Leadership and Civic Engagement (LEADS). The mission of LEADS is to develop and teach a leadership model based on the experiences of African-American women leaders. This model, Engaged Leadership, requires intellectual, personal and community involvement in activities that improve the quality of life for women, men and children.

Dr. Smith began her professional career in 1975 at Spelman College where she served as Assistant to the President. From 1981 to 1990, she was the Managing Director of INROADS, Inc., responsible for corporate placements for college interns. In 1991, Mrs. Coretta Scott King invited Dr. Smith to serve as Director of Development at the Martin Luther King, Jr. Center for Nonviolent Social Change. From 1994 to 1998, she directed the award-winning Atlanta Project at The Carter Center. In this capacity, she reported to former President Jimmy Carter. From 1998-2001, Dr. Smith was President and CEO of the National Council of Negro Women, founded by noted educator and civil rights activist Mary McLeod Bethune. Prior to rejoining Spelman College in 2004, Dr. Smith was CEO of Business and Professional Women/USA, a national membership organization that promotes equity for all women in the workplace.

Today, in addition to her work as Executive Director of LEADS, Dr. Smith is a member of boards for the following: American Institute for Public Service, "To The Contrary," a nationally syndicated television program, the Women's Leadership Exchange and the United States Women's Chamber of Commerce.

Dr. Smith was appointed by former President William Clinton to the National Women's Business Council and by former Secretary of State Madeleine Albright to the United Nations Beijing Plus Five Conference delegation. She has served as a member of the National Judging Panel for the National Women's Hall of Fame Inductees, the US Chamber of Commerce Committee of 100, a Trustee of the University of the District of Columbia and a judge for Lifetime Television's Lifetime Achievement Awards.

Dr. Smith holds a Doctorate of Education in Social Policy Analysis from Harvard University, a Masters in Sociology from Emory University, a Bachelor of Arts in Sociology from Spelman College, and honorary doctorates from Spelman College and Texas College. She has received numerous awards and recognitions, including the Emory University Alumni Medal, the American Association of University Women's Woman of Distinction Award, the National Association for the Advancement of Colored People Roy Wilkins Award, and the Johnnetta B. Cole Spelman College Alumnae Achievement Award.
