



At DLA Piper, diversity and inclusion are fundamental to our core values. We value and celebrate diversity and recognize the value that every individual with his and her varied life experiences brings to our Firm. This system provides them with the mentoring, real-time feedback and training necessary to meet those competencies. And we are currently piloting a new program that identifies and supports the career development of high-potential diverse lawyers. The Firm's goals for all of these programs are very simple: 1) we want to attract and retain the brightest and the best; and 2) curb the attrition of lawyers, particularly women of color, who feel that they have to make the choice between being a successful lawyer and the commitments in their personal lives. At DLA Piper, we believe our lawyers should have full integration of both.

But we don't stop here. Our diversity and inclusion leadership team, (comprised of our Chief People Officer, our Chief Operating Officer, our National Diversity and Inclusion Partners, our Director of Diversity & Inclusion, our Directors of Recruiting and Professional Development) meets regularly to develop and implement innovative strategies to ensure that our lawyers are receiving the training, recognition and access that they need to be successful lawyers and influential leaders within the profession and the Firm. We believe that through this collaborative approach to diversity and inclusion, we will continue to see meaningful progress in our goal of creating the world's most diverse global law firm.
